
ECIA actively maintains 203 ANSIaccredited standards domestically and participates internationally in producing standards through the International

Electrotechnical Commission (IEC).

The following new standard is currently under development: EIA-364-120 Electrolytic Erosion Test Procedure for Electrical Connectors

We have recently expanded our capabilities to accommodate remote reviewing of documents, submitting comments and voting on our new and revised standards.
