# Position Statement: Automotive Semiconductor Shortage

The ECIA has posted a document titled, "The Automotive Semiconductor Shortage – an Accident Waiting to Happen?" which sheds light on some of the reasons for the disruptions in automobile manufacturing globally. ECIA's President and CEO David Loftus, author of the paper, explained, "For the past several decades, the automotive manufacturing industry has driven one of the leanest and most demanding supply chains in the world, especially for electronics. Just-in-time manufacturing works great in a steady state environment. Unfortunately, with long lead-time items like semiconductors, when demand is volatile, as it has been in the past 12 months, the accompanying supply chain cannot react instantaneously."

# **NAM Takes Position on PRO Act**

# Sweeping Labor Overhaul Proposed with "PRO Act" Legislation

The <u>PRO Act</u> was reintroduced that proposes drastic changes to our nation's workplace and employment laws. Among the more than 30 provisions contained in the bill include:

- Eliminating the secret ballot in union elections;
- Removing Right to Work laws in 28 states;
- · Limiting the use of independent contractors;
- · Allowing unions to access private employee data; and
- Reinstating multiple Obama-era labor policies, including the joint-employer standard, persuader rule and ambush election rule.

The <u>NAM</u> strongly opposed the legislation when it was first introduced in 2019 and helped mobilize a grassroots effort against it in 2020. The NAM intends to work with CMA partners to oppose the bill and support the rights of manufacturing workers.
