# Country-of-Origin to Change for Hong Kong Products



U.S. Customs and Border Protection (CBP) issued on August 11 a notice that products produced in Hong Kong will now have to be marked as "Made in China."

This change in country-of-origin marking does not affect tariffs.

Products made in Hong Kong continue to not be subject to the "China tariff." The effective date is September 25, 2020.

# Coronavirus Impact Survey -Update 10

Developments over the past month on "Main Street" and "Wall Street" have revealed the triumph of hope (and a lot of government stimulus money) in battling the devastating economic impact of the COVID pandemic. Frightening levels of unemployment have seen dramatic improvements as the U.S. unemployment rate fell to 10.2% in July from a peak of

14.7% in April.

ECIA began conducting surveys of member manufacturing and distributor companies at the start of February to provide visibility on the ever-evolving impact of COVID-19 on the electronics components supply chain. It has been one month since the last ECIA survey focused on the impact of COVID-19 on the electronics components supply chain.
